### **Exhibitors Assignment:**

\*Gulf Coast Big Rig Truck Show, LLC (GCBR Truck Show) reserves the right, at its sole discretion, to determine eligibility of any potential exhibitor for inclusion in the show and may decline or prohibit any exhibit, exhibitor, or proposed exhibit not deemed to be suitable or appropriate to purpose of the show.

\*Offensive or derogatory slogans, language, artwork etc. will not be permitted.

\*GCBR Truck Show shall assign booth space and reserves the right to change the location assignment of booth space if it is in the best interest of the show or if it is required by any agency regulating the facility.

### **Rules and Regulations:**

\*GCBR Truck Show must approve all exhibits and displays.

\*Exhibitors may not erect signs, partitions or to display products in such a way to occasion injury or disadvantageously affect the display of other exhibitors.

\*No subletting, sharing or assignment of space will be permitted.

\*Plans for any questionable exhibits should be submitted to GCBR Truck Show for approval at least 30 days before show.

\*Promotional stickers shall not be placed on any portion of the Mississippi Coast Coliseum & Convention Center.

\*Soliciting outside of your booth space is not permitted unless given express permission by GCBR Truck Show Management.

### **Payment and Cancellations:**

\*A signed contract and payment must to be in the GCBR Truck Show office before a booth will be assigned.

\*Payment has to be paid in full or exhibitors will not be allowed to set/up their booth.

\*Notice of Cancellations must be received in writing to GCBR Truck Show.

\*Refunds will be determine by GCBR Truck Show.

### **Exhibitors Hall Schedule:**

\*The Hall will be open to exhibitors 1 hours before the show opens and 1 hour after the show closes
